

**AGRIPAK® FARM AND RANCH POLICY
DWELLING COVERAGE ENHANCEMENT
Coverage Summarization**

- OUTDOOR ANTENNAS AND TOWERS AND SATELLITE SYSTEMS – Increased from \$1,000 to \$5,000
- OTHER PRIVATE STRUCTURES APPURENANT TO DWELLINGS – Increased from 10% to 20% of Coverage A limit.
- SIGNS AND ENTRANCE GATES – Increased from \$2,500 to \$5,000.
- HOUSEHOLD PERSONAL PROPERTY (INCREASED SUB-LIMITS)
 - \$3,000 on "money," gift cards, gift certificates, vouchers, coupons, bank notes.
 - \$10,000 letters of credit, manuscripts, passports, stamps, philatelic property, bills, deeds and "securities."
 - \$5,000 on watercraft, including their equipment, furnishings, outboard engines or motors, and trailers;
 - \$5,000 on trailers not used with watercraft nor for farming operations or business purposes;
 - \$5,000 for "business property" on the "insured location";
 - \$2,500 for "business property" off the "insured location."
 - \$5,000 theft of furs, jewelry, precious and semi-precious stones, and watches;
 - \$10,000 theft of goldware, goldplated ware, silverware, silverplated ware, platinumware, platinumplated ware and pewterware.
 - \$10,000 theft of firearms and related equipment.
 - \$3,000 on electronic apparatus and accessories, while in or upon a motor vehicle or other land conveyance.
 - \$3,000 on electronic apparatus and accessories used primarily in connection with the operation or the farm or a business, while off the "insured location" and not in or upon a motor vehicle or other motorized conveyance.
- TREES, SHRUBS, PLANTS AND LAWNS – increased from \$500 to \$2,000.
- REFRIGERATED PRODUCTS - NOT "FARM PERSONAL PROPERTY" – Increased from \$1,000 to \$2,000.
- CREDIT CARDS AND ELECTRONIC FUND TRANSFER CARDS OR OTHER ACCESS DEVICES; FORGERY; COUNTERFEIT CURRENCY – Increased from \$5,000 to \$10,000.
- SUMP OVERFLOW AND WATER BACKUP FROM SEWERS, SEPTIC OR DRAINS – Increased from \$5,000 to \$25,000.
- REMOVAL OF FALLEN TREES – Increased to \$2,000 (\$1,000 for any one tree).
- ELECTRONIC DATA AND RESTORATION – \$2,000 (new coverage).
- LOCK REPLACEMENT COST - \$1,000 (new coverage).
- FIRE EXTINGUISHER RECHARGE - \$1,000 (new coverage).
